



2021 Sunnyland Board - Election Proceedings

October 1, 2020

Fellow Sunnyland Members:

It is that time of year again in which we prepare for our Sunnyland Board of Directors (BOD) elections. These election ballots will be sent to you electronically if you have email, or by mail if you have no email address. They are to be counted and the results read at our Sunnyland Annual Meeting at The Mount Dora Yacht Club, held on Saturday November 7th, in Mount Dora, Florida. Due to COVID-19 we will not have our annual banquet this year. There is a memorial boating event scheduled in honor of Bill Root our long time serving secretary on Friday November 6th. Details of the boating event will be posted on the Sunnyland website.

BOD guidelines:

- The BOD is made up of 11 voting members – (1) President, (1) Vice President, (1) 2nd Vice President, (1) Treasurer, (1) Secretary, (5) Directors, (1) Immediate Past President
- The President, Vice President and 2nd Vice President can serve up to 2 consecutive 1 year terms – must be voted in each year
- The Treasurer and Secretary can serve unlimited consecutive 1 year terms – must be voted in each year
- The (5) Directors shall be elected to terms of two years with at least three (3) directors elected on even years and two (2) directors elected on odd years. The Directors can serve unlimited consecutive 2 year terms.
- The term year is defined as January 1 – December 31 of the calendar year.

To address our current 2020 BOD, we would like to thank the following:

- Joe Coleman – 2nd consecutive 1 year term as our President
- Danny Ross – 2nd consecutive 1 year term as our Vice President
- Howard Wanamaker – 2nd consecutive 1 year term as our 2nd Vice President
- John Hough – 2nd consecutive 1 year term as our Treasurer
- The late Bill Root – 8th consecutive 1 year term as our Secretary
- Bruce Kester - Immediate Past President
- Our 2019 Class of Directors elected November 2018 - Jack Bingham and George Emmanuel, serving 2nd year of a 2 year term
- Our 2020 Class of Director's elected November 2019 – Bill Robbins, Mike Yobe and Walter "Skip" Frey, serving 1st year of a 2 year term

The Nominating Committee recommends you cast a vote for each of the Class of 2021 nominees that will be on the ballot. You also have the right to nominate from the floor for any board position. This is your opportunity to vote for a candidate that is not currently on the ballot – please include their name and position you wish for them to fulfill. Note that for your write-in vote to count, your candidate must be in good standing with the Sunnyland Chapter and meet all of the election criteria for BOD eligibility defined in our Chapter By-Laws. The candidates will be selected to the board by popular vote.

This year we will be voting electronically. We will be using a secure voting process by electionbuddy.com. For those without an email address, a paper ballot will be mailed with completion instructions.

You will receive your ballot electronically by electionbuddy on no later than October 6th. If you do not see the email, please check your junk mail filter.

When you get your ballot from electionbuddy, you will be able to click on the link to complete your ballot. The results will only be accessible by the election committee. The election will close **November 6th, 2020**. Thank you for your contribution to this process and for making Sunnyland one of the greatest ACBS chapters.
